### **Approval of 2017 Lease Project Bids**

#### **Approval of Bus Purchase**

Mr. Richie explained that again the Central Indiana Educational Service Center (CIESC) bus bid program was used to solicit online bus bids. This program is cost effective and timely. Three companies provided bids: Kerlin, MacAllister, and Midwest Transit. After consideration of the bid information, it is recommended that the Board approve the purchase of three Thomas 72 passenger school buses from Kerlin Bus Sales at a total cost of \$232,169 after trade-in allowances for the three proposed buses.

Mr. Menis made a motion to approve the proposed recommendation of bus purchases from Kerlin Bus Sales as presented. Mr. Stalbaum seconded the motion; motion passed 4-0.
