#### North Judson – San Pierre Elementary School Parent Involvement Policy 2023-2024

North Judson-San Pierre Elementary intends to follow the parental guidelines under the No Child Left Behind Act of 2001. North Judson-San Pierre Elementary will distribute the guidelines to parents of students participating in the Title I program, and parents will update them periodically.

#### Guidelines

• Convene an annual meeting to inform, discuss, and demonstrate the literacy intervention in kindergarten, first, and second grades.

• Explain the requirements and rights of parents. Each child will receive appropriate activities to complete at home. These activities are for practicing skills and strategies. In grades one and two, the student will read a take-home book relevant to their independent reading level. Kindergarten students take home activities to practice recognizing and reproducing letters and sounds.

• Involve parents in an organized, ongoing, and timely way to plan, review, and improve programs. A Parent Advisory Council will meet at least once a year and act as a liaison between parents and the program when appropriate.

• Provide the parent of participating students with information regarding the program. Newsletters and Title I contact information are available on the school's website: https://www.njsp.k12.in.us. The newsletters contain ideas and materials on how to improve a child's literacy performance. Parents may reach their child's reading teacher by phone, note, or e-mail, and they will respond to any parent suggestions or concerns as soon as possible.

• Ensure to the extent possible that the information sent home is in a language the parents can understand. We will provide parents who speak Spanish with only an interpreter when possible for parent-teacher conferences.

• Provide materials and training on how parents can improve their child's achievement through newsletters, the web page, and any specific training requested by the parents to the reading teachers, the program administrator, or the Parent Advisory Council.

The curriculum for kindergarten is based on the Indiana State Standards and focuses on phonological awareness and mastery of essential skills. The curriculum for grades one, two, and three comes from the Indiana State Standards for English/Language Arts. It focuses on grade-level reading proficiency, which includes accuracy, fluency, and comprehension.
Academic assessment tools for kindergarten students are checksheets based on the Indiana State Standards. The measurement tools for students in grades one and two are running records for accuracy and fluency, plus retelling for comprehension. The measurement tools for third-grade students are running records for accuracy, fluency, and

comprehension. Parents may request progress statements on their child's progress throughout the school year.

### TITLE I LEA PARENT INVOLVEMENT POLICY
