Driver's Ed. Program

Mrs. Johnson provided the board with a proposal for the Athletic Department restructuring.

Snow Make-Up Days

Mrs. Johnson discussed the snow make-up days. We have used all three days and added three additional days to the end of the calendar, any additional days will also be added to the end of the calendar. Currently the last student day is June 2^{nd} , except for seniors who will make up days through alternative learning activities as graduation remains on Sunday, May 31^{st} .

General Assembly Update

Mrs. Johnson reported on recent news with the General Assembly including information about the Scholarship Grant Organization (voucher program). Though currently there is no existing bill proposed in this session of the General Assembly, HB 1001 could be expanded to also cover the voucher program. In this House budget the SGO scholarship fund has been expanded from \$7.5 million to \$12.5 million, and would automatically expand if the cap is reached. The second voucher expansion in the House budget is to remove the \$4800 cap on vouchers, which would mean taxpayers pay the entire tuition for a private school. Mrs. Johnson encourages everyone to contact their local legislators, ours is Senator Ed Charbonneau concerning the voucher expansion.

Other

Mrs. Goin read a statement "The Board and the Administration learned for the first time last Friday, March 13, of some concerns that parents had regarding the athletic department. I want to assure everyone that all of these concerns are being thoroughly investigated. Until that investigation is completed there is nothing more that the Board or the Administration can say."
