#### **Approval of Corporation Plans – Final Reading**

Dr. Zupin discussed the components of the corporation's wellness plans, much of which are derived from Federal and State guidelines. The Technology plans which are derived from our Technology planning grant and Strategic and Accountability components were also discussed. Mr. Bacon made a motion to approve the Corporation Plans as presented. Mr. Stalbaum seconded the motion; motion carried 5-0.

## **Approval of Jr-Sr High Painting Project**

Dr. Zupin stated that the painting project for all of the Jr-Sr High School classrooms will begin when school is out. Mrs. Kersting Rudd made a motion to approve Jr-Sr High Painting Project as presented. Mr. Bacon seconded the motion; motion carried 5-0.

#### School Handbooks- 1st Reading

Presentations were given by Mr. Polite and Mrs. Berndt regarding the school handbooks. Much of the discussion revolved around transportation changes and ensuring the language promotes consistency and routine as opposed to adding difficulty to a family's specific dynamics. Dr. Zupin indicated that administrators would continue to work on the language and share with our board next month. It was proposed that a policy for a weighted grades system be put in place beginning with the class of 2023.

#### **Superintendent's Report**

Dr. Zupin was excited to say "We are in the home stretch, ILEARN testing will begin on Monday, April 22. Friday, April 19 will be our last eLearning day. Students' last day will be May 24 with Graduation to be on June 2". It was stated that the employee insurance would be renewed with dental and vision moving to United Healthcare, streamlining

with our current Healthcare/medical insurance provider. It was also discussed that the technology grant would be used to purchase IPads through Apple with the ultimate goal to be that every student has a device. On April 24 Fanning and Howey will be doing a walkthrough at the elementary and middle school as well as the bus garage with a report on any findings to be shared in May. Technology planning dates were mentioned again with visits to schools in early May and an Apple Leadership Work Session in June/July.
