#### **SRO Update**

Dr. Zupin reported on the School Resource officer. Stating that "We will start in January selecting the right officer and the town of North Judson will be picking up the cost of the SRO's health and other benefits. A grant we received will pay \$25,000 of the SRO's \$50,000 salary. We need to hire the officer in December and on January 6 we will meet and come here at our January meeting and make a presentation".

#### **Superintendent's Report**

Dr. Zupin reported on the TAG Stipend, aiming for the grant to be distributed to the NJ-SP teachers on December 6, 2019. Dr. Zupin noted Thanksgiving Break with no school on November 27, 28, 29 and November 19 (Red for Education) day to be made up on February 17 (President's Day). Dr. Zupin discussed the Elementary Project, adding that on December 2 we will have a work session to discuss the project and we will hear from Fanning and Howey. Dr. Zupin stated "In January, 2020 we need to put out notices so the community knows and that in February, 2020 there will be preliminary determination at the board meeting to talk about the scope of work and there will be a public hearing. In late summer bonds will be issued and we will be able to do the bulk of work in the summer of 2021".

Other

Mr. Stalbaum discussed his experience attending Red for Education in Indianapolis.
