Elementary Project Update

Dr. Zupin explained that bids came in very favorably, stating "The Transportation Center can be done within the scope in March 2021- August 2021." Additional work on the Elementary School was explored such as additional electrical in classroom, playground enhancements, technology upgrades and window coverings. Dr. Zupin stated "We can now organize and plan other work knowing that we will not have to use the other funding sources for the transportation center." Some things discussed were the gym floor and bleachers, upgrading roofs at both buildings and Central Office, track redone, scene shop being organized, ticket booths, sidewalk work in conjunction with Town of North Judson and Technology upgrades.

COVID-19 Update

Dr. Zupin updated that the Jr-Sr High School will be finishing the semester (5 days) virtual due to an increase of student cases, other illnesses and families choosing to go virtual for the last week. Timing of the cases helped in making the decisions- last week of the semester, older students make the move much easier adding that the Elementary cases are not as significant. Dr. Zupin added that athletics would be suspended for a week due to 2 of 4 teams being quarantine directed. All to return January 5, 2021.
