# **Approval of JESSE Service Agreement**

Dr. Zupin presented the JESSE Service Agreement with Knox, OD, and NJ-SP for Special Education which lays out shared services for the students and allows for efficiency of services and funds. Mrs. Kersting Rudd made a motion to approve of JESSE Service Agreement as presented. Mrs. Akers seconded the motion; motion carried 4-0.

# Approval of Amendment to Non-Certified Handbook & Pay Schedule

Dr. Zupin acknowledged the new category of instructors in the amendment to the Non-Certified Handbook, being classroom instructors without DOE licensure or bachelor's degree which will be special courses. Mrs. Akers made a motion to approve of Amendment to Non-Certified Handbook & Pay Schedule as presented. Mr. C. Stalbaum seconded the motion; motion carried 4-0.

### **Approval of Education to Operations Fund Transfer**

Mr. Tunis explained to the board that this is the sixth of ten transfers (March-December), and each transfer will be \$100,000 with the total amount being transferred at \$1,000,000. This is different than in the past to keep the financials steadier instead of creating large fluctuations.

Mrs. Kersting Rudd made a motion to approve of Education to Operations Fund Transfer as presented. Mr. C. Stalbaum seconded the motion; motion carried 4-0.

## **Approval of Monetary Donation**

Mr. Tunis presented a monetary donation from RCR Cabinetry in the amount of \$150.00 which will be used toward 6<sup>th</sup> grade school supplies.

Mr. C. Stalbaum made a motion to approve of Monetary Donation as presented. Mrs. Akers seconded the motion; motion carried 4-0.

### **Principal Report**

Elementary School Principal, Dr. Morikis reported Teachers and Staff have been relocated and are helping guide students and helping them get into routine. The front office secretaries are also helping everyone. Along with Art, Music, and PE we also now have Social and Emotional Learning that will be working with students on interactions.

Jr-Sr High Principal, Mr. Orkis was pleased to report that at the start of the school year all the students are happy to be back, and things seem to be normal. Attendance has been excellent compared to past years and they are all glad to be fully back into it. For students that drive, due to security reasons there are two main access points to keep an eye on students, we have great kids, and they understand our expectations. We are now offering an officiating course so students can become licensed officiants. They can help us cover finding officiants, there is a lot of good things and expectations are high. It has been a great start to the year.

Dr. Zupin and Mr. Radtke updated the roof is a huge focus, new gym work is being done and mechanical work in the building.
